<i>Societies with higher GDP tend to have higher life expectancy. Societies with greater equality achieve longer life spans than more unequal societies.</i>	
<b>Maternal Mortality</b>	70
<i>The half a million women who die each year from complications related to pregnancy are mainly from the poorest people in the least developed countries.</i>	
<b>Child Mortality</b>	72
<i>Children in developing countries become sick and often die of preventable or treatable diseases.</i>

<i>Access to healthcare is worst in low-income countries, in rural areas and for the poor. The rich benefit most from government health expenditure.</i>
